 Three weekly collections would affect young families (i.e. nappies), concerns over unsanitary waste and hygiene. The weight of the bin would also be increased making it difficult to manoeuvre.
 - <u>GARDEN WASTE</u> This would no longer be provided for free. In this option everyone who wishes to use a fortnightly garden waste collection service will be able to do so throughout the year, for an annual charge of approximately £40.

The improvements to recycling rates of the Council would be better met by additional Central Government funding and education rather than cuts in funding and service.

17/495 TO CONSIDER CONTACTING CBC/BUSINESSES REGARDING CONSIDERATE PARKING

Councillor Channon advised that he has been approached by residents who have raised concerns over vehicles parking outside business with little consideration. Members acknowledged that PCSO's used to give advisory notices but this has since been removed from their remit. The Parish Council has also looked into the possibility of using the Library car park 'out of hours' but this had not proved to be possible due to unlocking/locking of the gates and additional insurance. Members felt this was an important issue and it could be considered as part of the traffic calming scheme. **ACTION: Take under consideration in traffic calming scheme.**

17/496 REVIEW OF RISK ASSESSMENT (HIGHWAYS & ENVIRONMENT ONLY) AND AGREE ACTION PLAN

Members reviewed the Risk assessment report and action plan. The majority of risks have been highlighted as low risk with litter/anti-social behaviour being highlighted as medium risk. Members felt that regular Streetwatch patrols would assist with this problem. ACTION: Office to promote the Streetwatch scheme on the Parish Councils Social media/website and newsletters.

17/497 UPDATE ON TRAFFIC CALMING SCHEME PHASE 2

Central Bedfordshire Council's Principal Highways Officer has advised that Phase 2, Traffic Calming works for Hexton Road are to be scheduled for late July. This will coincides with the start of the school summer holidays. Prior to the commencement of works notices and road closures will be arranged by Highways. The updated drawing and detailed plan are still outstanding and once received a meeting will be arranged with Central Beds Highways team. **ACTION: office to request updated drawing and detailed plan and once received arrange meeting.**
