Risk items at Arnold Recreation Ground Fitness Equipment:

• Signage to conform to correct legislation – Low risk.

#### Risk items at Norman Road Play-area:

• Slight wear to Junior swing chains – Groundsman to monitor and replace when necessary.

#### Risk items at Arnold Recreation Ground Play-area:

- Wear of ground around the entrance gate paving slab to be replaced with grass matting to alleviate this problem in the future.
- Giro-Spiral seat damaged. Replacement seat on order.
- Giro-Spiral safety surface worn. New surface on order.
- Decay to timber frame around Aeroskate equipment Replacement of safety surface being investigated.

<u>ACTION</u>: The Clerk to monitor the progress of the RoSPA Report recommendations as approved by the Council.

### 17/047 CONSIDERATION OF AREA OR USE OF SKIP FOR NON-COMPOSTABLE GREEN WASTE AT ALLOTMENTS.

Following the removal of the skip for use by Allotment holders, complaints had been received regarding the disposal of non-compostable green waste at the allotments. After discussion, the Committee agreed to a trial of opening the skip for two Sundays a year to dispose of Raspberry canes, Brambles and other non-compostable green waste. A letter to be sent to allotment holders advising that should the use of the skip be abused, the facility would be withdrawn. ACTION: Assistant Clerk to draft letter for Full Council approval.

### 17/048 CONSIDERATION OF PURCHASE OF REPLACEMENT SWINGS FOR ARNOLD RECREATION GROUND.

Three quotations were sought for replacement Junior and Cradle swings at Arnold Recreation Ground and were disseminated to all members prior to the meeting. Committee requested confirmation that Proludic had quoted for two Junior and two Toddler swings and to confirm lead time of installation. Grants for the replacement swings to be investigated. ACTION: Defer to Full Council for approval.

No further information had been received from the organiser of the Boot Camp. <u>ACTION</u>: Defer to next meeting following receipt of information.
